On 23 September 2019, the High Court appointed the Official Receiver as liquidator of the companies listed below on the petition of the companies' directors. Simultaneously, the Court also appointed Simon Appell, Alastair Beveridge, Dan Imison and Ben Browne as Special Managers of the companies to support the liquidator.
